COST: The cost per 10'x 10' space is \$125. This fee is non-refundable, see exception below.*

Please note that vendors producing oil and grease by-products will be required to pay a \$50 per day refundable clean-up fee. Please submit this as a separate check.

Vendor Instructions and Guidelines
2025 Christkindl Markt at University Plaza
Hagerstown, Maryland
December 12 & December 13, 2025

VENDOR HOURS ETC, please initial:

___ Friday, December 12, 3 pm-8 pm, set up will begin at noon.

___ Saturday, December 13, 10 am to 4 pm, tear-down will begin at 4 pm and vendors need to be packed and ready to leave no later than 6 pm.

___ In case vendor sells out, vendor will keep a presence at the event, packing up no earlier than 4pm on last day.

___ Vendor will park in designated parking areas only, as marked on map provided the week before the event via email

- Vendors may secure their belongings in their tent overnight. Security will be provided overnight by a licensed security company and the Plaza will be locked.
- The event will be held as long as it does not snow or rain significantly. A determination to cancel the event due to weather will be made the morning of the event.

ARRANGEMENTS/RESTRICTIONS

- Space Size: Space requirements must be indicated on the Application Form and in the case of double space reservation, double the space fee is required.
- Only one (1) vendor per booth.
- Set-up: Vendors will be responsible for providing their own set-up, (i.e., tables, chairs, tents, small propane heaters etc.).
- Tents are required and sides are highly recommended. We found sides offer useful protection against the elements, if needed. LED outdoor lights can really enhance your tent and use very little electricity.
- All vendors must supply their own outdoor extension cords and power strips to access electricity in the plaza.
- Food vendors accepted must apply for and receive a temporary food permit from the Washington County Health Department. Your Washington County Health Permit must be shown at all times. If you have questions, call 240-313-3400.
- Food selection will be based on the menus chosen by the Committee. Only those food and drink items selected may be sold - NO EXCEPTIONS.
- Vendor booths WILL NOT EXCEED PROVIDED SPACE.
- Vendor agrees that if any of these guidelines are not followed, the Committee has the right to revoke said vending privileges, close said vendor's stand, and have them removed from the site without refund.
- Vendor will be responsible for taking away all grease from your vending operation. Dumping grease on the ground or in storm drains is strictly prohibited. Grease shall be stored in appropriate containers. Do not utilize trash barrels or boxes for grease.
- Vendors doing on-site cooking must meet requirements set forth by the City Fire Marshal.
- All vendors will be required to sign a Hold Harmless Agreement with the Christkindl Markt.
- The City prohibits the driving of any stakes, nails, etc., into the vending area for any reasons.
- The City prohibits the use of the decorative lamp posts for securing tables, booths, etc. It is also prohibited to tape, wire, tie or otherwise hang anything from these lamp posts.
- ***Vehicles may be parked in Hayes Alley and on Washington Street for unloading purposes only and must then be moved to designated parking lots and garages. Large trailers are best parked in the Main Lot off North Potomac Street, see map. Parking is only allowed in designated parking lots and garages.***
